OBJECTIVE AND INVESTMENT POLICY

The investment objective of the Fund is to preserve capital and provide liquidity by investing in Euro denominated cash holdings.

The Fund will invest in a global range of cash deposits and short-dated term money market securities which may include short term commercial paper, bankers' acceptances, government securities and certificates of deposit, and securities issued by governments, government agencies and corporate issuers.

At least 80% of the Fund's assets will consist of money market securities or deposits which, at the date of acquisition, have a maturity of not greater than one year. The Fund will invest only in high quality money market instruments, as determined by the Investment Manager (or its delegate).

The Fund will invest in money market instruments which have a residual maturity of up to and including 397 days and may also invest in money market instruments with a residual maturity until the legal redemption date of 2 years or less, provided that the time remaining until the next interest rate reset date is 397 days or less. For that purpose, floating rate money market instruments and fixed rate money market instruments hedged by a swap arrangement shall be reset to a money market rate or index.

The Fund will maintain a weighted average maturity of 6 months or less and a weighted average life of 12 months or less. The calculation of both will take into account the impact of deposits and any repurchase or reverse repurchase agreements used by the Fund.

Weighted average maturity is a measure of the average length of time to maturity of all of the underlying instruments weighted to reflect the relative holdings in each instrument, assuming that the maturity of a floating or variable rate instrument is the time remaining until the next interest rate reset date rather than the time remaining before the principal value of the instrument must be repaid, while weighted average life is the weighted average of

the remaining life (maturity) of each instrument held, meaning the time until the principal is repaid in full.

At least 7.5% of the Fund's assets will be daily maturing and at least 15% of the Fund's assets will be weekly maturing. No more than 5% of the Net Asset Value of the Fund will be invested in the debt securities including, without limitation, commercial paper, promissory notes, floating rate notes and certificates of deposit, of companies, other than banks, with a credit rating of less than A1/P1.

The Fund may also invest up to 10% of its assets in aggregate in other collective investment schemes provided that they are Money Market Funds. Such collective investment schemes may not be feeder funds or fund of funds.

The Fund may use financial derivative instruments (instruments for which the price is dependent on one or more underlying asset, 'FDI') for the purposes of hedging and efficient portfolio management. This can be to achieve the investment objective, to hedge a given investment or to hedge against anticipated movements in a market or other sector or to manage the portfolio more efficiently. FDI may enable the Fund to obtain market exposure in excess of the value of the Fund's assets. The Fund is not intended to be leveraged. The Fund may not invest in FDI that would result in losses exceeding the Net Asset Value of the Fund. The use of FDI may multiply the gains or losses made by the Fund on a given investment or on its investments generally.

Income and capital gains from the Fund are reinvested. No dividends will be paid in respect of any class of shares in the Fund.

You can buy and sell units in the Fund on demand every day which is a bank business day in Ireland or the United Kingdom.

Recommendation: Investment in the Fund should be viewed as short to medium term.

The Fund is rated 1 due to the nature of its investments which include the risks listed below:

Credit risk: The risk that an organisation does not pay out on a bond or other trade or transaction when it is supposed to.

Liquidity risk: Lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.

Operational risk: All funds are subject to the risk that something could go wrong in the day-to-day running of an organisation.

Fixed income: Investing in fixed income securities offers the chance to gain returns through growing capital and generating income. However, there is a risk that the institution that issues the security could fail to pay out on the bond, causing the Fund to lose its initial investment and expected income from the security. Fixed income values are likely to fall if interest rates rise. If interest rates change considerably, as bonds mature, there is no guarantee that bonds of a similar type and yield will be available to replace them.

Sovereign debt: Investment in sovereign debt securities might involve special risks. The issuer of the debt or the governmental authority that controls the repayment of the debt might be unable or unwilling to repay principal or interest when due. Economic uncertainty might increase the volatility of market prices of sovereign debt.

Financial derivative instruments (FDIs): The use of FDIs is highly specialised. FDIs are used to increase, lower or maintain

the risk level of the Fund. The loss on FDIs may exceed the amount invested and may have a negative effect on your investment. Risks associated with FDIs include the risk that the other party with which the Fund enters into an FDI will not meet its payment obligations.

Counterparty risk: The insolvency of any institutions providing services such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.

Sector specific: Investment risk is concentrated in specific sectors, countries, currencies or companies. This means that the Fund is more sensitive to any localised economic, market, political or regulatory events.

Fund of Funds: The Fund is a fund of funds, which means that the Fund invests in other Underlying Funds and each of the

Underlying Funds into which it invests may in turn be subject to risks arising from the investments which that Underlying Fund makes. There can be no assurance that suitable Underlying Funds can be successfully selected or that the managers of the Underlying Funds will be successful in their investment strategies.

Multi-Manager or Fund of Funds: The Fund may in certain circumstances invest directly rather than through Underlying Funds. In such cases, the Fund will be directly subject to the risks identified here and in the supplement for the Fund.

CHARGES

The charges you pay are used to pay the cost of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


The entry and exit charges shown are maximum figures. In some cases, you might pay less – you can find this out from your investment advisor or distributor.
