## **Asset Transfer Form**

Conexim Advisors Ltd ("**Conexim**") and Pershing Securities International Ltd ("**PSIL**") do not charge for transfers into your account, however your current provider may charge you a fee to cover their administration costs.

Conexim can only accept dealing instructions (for sales) in these securities when the transfers have been completed and your securities have been re-registered into your PSIL nominee account. The time this will take will depend on the processing time of your current provider. It may not be possible to transfer all securities, for example, suspended or bankrupt securities.

In some cases the dividends on your holdings may arrive to your account with your current provider after the transfer has taken place. This occurs when the record date for the dividend payment is before the transfer to PSIL and the pay date is after the transfer date

If you have any securities held in certificate/paper format that you wish to transfer into your account you will need to send us the certificates. We will review the certificates and then forward you the relevant forms to enable the transfer to your account at PSIL.
